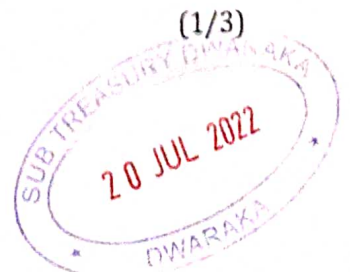

This MOU will help to do collaborative research work and biodiversity comparison in the field of Zooplankton between coastal and oceanic waters of Abudhabi and Kerala.


Duration
