



MEMORANDUM OF UNDERSTANDING (MoU) Between Mary Matha Arts and Science College, Mananthavady, Kerala and Barkia College (Autonous) Timeseo Teority - J

Park's College (Autonomous), Tirupur, Tamilnadu

MEMORANDUM OF UNDERSTANDING is made and entered into on this March 16, 2023 between MARY MATHA ARTS AND SCIENCE COLLEGE, MANANTHAVADY, KERALA (MMASC) on the ONE PART and the PARK'S COLLEGE (AUTONOMOUS), TIRUPUR, TAMILNADU (PARK'S), on the OTHER PART (who for the purpose of this MoU are hereinafter individually referred to as "PARTY" and collectively referred to as the "PARTIES").



AND Whereas MMASC is involved in education and Research in Arts, Science Commerce AND Whereas PARK'S is involved in education and research in Arts, Science, Commerce, Business Administration and Management

Now, therefore, in consideration of the premises and mutual covenants hereinafter contained, the parties hereto agree as follows:

1. Objectives

1.1 To associate in providing student exchange, faculty exchange and training at PARK'S and MMASC

1.2 To collaborate in organizing seminars, conferences and workshops between Research Centers of both the Institution.

- 1.3 To collaborate in conducting outreach programmes in the community.
- 1.4 To collaborate in conducting hands on training sessions.
- 1.5. Research Collaboration with Computer Science Departments

2. Implementation

- 2.1. The parties agree to constitute an implementation Committee comprising the following Participants.
 - 1. The Principal, Park's College (Autonomous), Tirupur, Tamilnadu
 - 2. The Principal, Mary Matha Arts and Science College, Mananthavady, Kerala

3. General Provisions

- 3.1 Based on the requirements the implementation committee shall, in consultation with the faculty and professionals, decide on program / event and the mode of cooperation during the tenure of this Collaboration.
- 3.2 The institution organizing an item of works shall have the nodal responsibility for mobilizing resources and the conduct of such works.
- 3.3 Each party shall bear the respective costs of carrying out the obligation under this agreement. Neither party shall make a 'claim against the other party for any expenditure unless such expenditure has been agreed upon in writing between the parties.
- 3.4 Any dispute or difference arising between the parties shall be settled by mutual agreement. The disagreements at the operating level shall be forwarded to the respective higher officials for appropriate resolution.
- 3.5 Nothing in this understanding is intended to affect other cooperation or collaboration between the Parties.

4. Tenure and Termination

4.1 This MoU shall come into force in MARCH 16, 2023 upon signatures by the authorized signatories of the Parties and shall be valid for three years. It may be amended by mutual written agreement and may be terminated at any time by either party upon one month's written notice to the other party

The modifications/ changes shall become part of the MoU and shall be effective from the date on which they are executed, unless otherwise agreed to.

6. Assignment

6.1 This MoU is based on the professional competence and expertise of each party and hence neither party shall transfer or assign this agreement, or rights or obligation arising hereunder, either wholly or in part, to any third party.

This MoU has been executed in two originals, one of which has been retained by PARK'S and the other by MMASC
