### 1. Objectives

- 1.1 To associate in providing Student Exchange, Faculty Exchange and Training at Mary Matha Government Aided Arts and Science College and AVPCAS
- 1.2 To collaborate in organizing Seminars, Conferences and Workshops.
- 1.3 To collaborate in conducting Outreach Programmes in the community.
- 1.4 To collaborate in conducting Hands-on-Training sessions.

### 3. General Provisions

- 3.1 Based on the requirements the Implementation Committee shall, in consultation with the Faculty and Professionals decide on Program / Event and the mode of cooperation during the tenure of this Collaboration.
- 3.2 The Institution organizing an item of works shall have the nodal responsibility for mobilizing resources and the conduct of such works.
- 3.3 Each party shall bear the respective costs of carrying out the obligation under this agreement. Neither party shall make a claim against the other party for any expenditure unless such expenditure has been agreed upon in writing between the parties.

3.5 Nothing, in this understanding is intended to affect other cooperation or collaboration between the Parties.

#### 4. Tenure and Termination

4.1 This MoU shall come into force from **December 30<sup>th</sup>, 2024** upon signatures by the authorized signatories of the Parties and shall be valid for **THREE** years. It may be amended by mutual written agreement and may be terminated at any time by either party upon one month's written notice to the other party.

4.2 All joint activities not completed at the expiration or termination of this understanding may be continued until their completion under the terms of this understanding.

#### 5. Amendments

5.1 This MoU represents the entire understanding between the parties and supersedes any and all understandings either oral or written hitherto with respect to the subject matter of this understanding.

5.2 No amendment or modification of the MoU shall be valid unless the same is made in writing by both the parties and specifically stating the same to be an amendment of the MoU. The modifications / changes shall become part of the MoU and shall be effective from the date on which they are executed, unless otherwise agreed to.

#### 6. Assignment

6.1 This MoU is based on the professional competence and expertise of each party and hence neither party shall transfer or assign this agreement, or rights or obligation arising hereunder, either wholly or in part, to any third party.
